2026 Sheriff and Constables Fee Schedule

Pursuant to Local Government Code section 118.131, the Court approves the 2026 Sheriff and Constables Fee Schedule, attached hereto as Exhibit "1." The Court finds the fees are reasonable and not higher than necessary to pay the expenses of providing the services described in Exhibit "1." Notices of the fee amounts shall be posted in the offices of the County officials who are authorized to charge the fees, in the County Courthouse, and at a public place in each Commissioner's Precinct.

The fees set forth in Exhibit "1" shall be effective January 1, 2026.

Writ Cancellation Fee (for Writs of Execution and Orders of Sale) Plaintiff's direction to withhold or release levy, withhold collection, cancel, or recall a writ, after the Sheriff or Constable has commenced in collection efforts, and/or prior to going to sale. This fee, plus commissions and any and all costs incurred by the County shall be paid by Plaintiff.	\$250.00
Complaint to Remove Person Occupying Dwelling Without Owner's Consent	\$ 180.00
Stand-By Fee for Complaint to Remove Person Occupying Dwelling Without Owner's Consent: This fee is invoiced at a per Deputy/per hour rate to the property owner/agent requesting that the Deputy(ies) remain on the property to keep the peace while the owner/agent changes any locks and removes any personal property. This fee is calculated from the time of such a request.	\$60.00
